Essential Qualifications (for the post of Manager (Legal) 'Group-A' (Unreserved) in Haryana State Warehousing Corporation (Cat. No. 1):

- (i) Graduate alongwith LLB (Professional) in 1st division with 10 years enrollment as an advocate and having experience in handling legal matters in public sector undertaking/banks.
- (ii) Knowledge of Hindi/Sanskrit upto Matric standard or Hindi as one of the subject in Higher Education.

Note:- The experience will only be counted after acquiring the basic minimum qualification.
