Essential Qualifications (for the post of Chief Manager (P&A), Class-I) (Cat. No. 1) :-

- (i) Post graduate with minimum 2nd Division in social work having specialization in Personnel Management & Labour Welfare or Public Administration/minimum 2nd division with a postgraduate diploma in Personnel Management & industrial relations from a recognized University or M.B.A.
- (ii) Law Graduate from recognized University.
- (iii) At least 10 years relevant experience out of which seven years should be in a supervisory capacity, relating to Administration/establishment work in a Govt. Quasi-Govt. Public Sector undertaking or an organization in Private Sector.
- (iv) Hindi/ Sanskrit upto Matric Standard or Higher Education.

Essential Qualifications (for the post of District Attorney (Group-A) Cat. No. 2):-

- (i) Degree of Bachelor of Law from a recognized University.
- (ii) Should have practised as an advocate for a period not less than seven years.
- (iii) Hindi or Sanskrit up to Matric Standard or Higher Education.
