- a) MBBS or an equivalent degree from any University recognized by the Medical Council of India.
- b) Having been registered as Medical Practitioner with Haryana State Medical Council or any other Medical Council in India.
- c) Must have passed Hindi/Sanskrit up to Matric Standard or Hindi/Sanskrit as one of the subject in higher education.
