## CORRIGENDUM

In partial modification of Adv No. 8(7) of 2015 for the post of Assistant Engineer (Civil, Mechanical and Electrical) in Irrigation Department published on 08.02.2016 in The Hindustan Times (Delhi, Chandigarh), The Tribune (Delhi, Chandigarh), Dainik Bhaskar (Chandigarh, Haryana), Dainik Jagran (Chandigarh, Haryana) it is hereby announced for the general information of the candidates that the Government of Haryana in Irrigation & Water Resources Department, Haryana, has intimated that the matter for Horizontal reservation of Physical Handicapped has been examined in view of the Government instructions dated 15.07.2014. The last date for submission of online application form of all these posts is hereby extended upto **31.07.2017** (closing date), date for deposit of application fee in any branch of State Bank of India upto **03.08.2017 (2:00 PM)**. The age will be calculated as on **1.8.2016** and all the candidates who had applied earlier in response to the Advt. No. 8(7) of 2015 need not apply again as their previous applications will be considered if they are otherwise found eligible. It is clarified that the age of these candidates who have applied earlier will also be calculated as on **1.8.2016** for the purposes of assessing their eligibility. However such candidates can update their qualification, category & experience etc. The eligibility with respect to qualification etc. will be considered as on the last date of submission of application forms for these posts i.e. **31.07.2017** (Closing date).

(Note:- The candidates are advised/directed to retain the hard copies of their online application form with them so that they should not face any problem in sending the hard copy to the Commission as and when required by the Commission at later stage within the specified period. This would be required from only those candidates who qualify for the interview. In case the candidate fails to submit the hard copy of the application form alongwith all documents relating to his claim in the application form e.g. age, category, domicile, experience, etc. the candidature of such applicant shall not be considered in the further selection process and would be liable for being placed as not qualified for interview and thereby rejected.)
