CORRIGENDUM

In partial modification of Advt. No. 12(3)/2015 and corrigendum dated 06.05.2016 for the posts of Assistant Labour Commissioner, Labour Department, Haryana published on 28.03.2016 and 07.05.2016 in various Newspapers (The Times of India (Delhi, Chandigarh), Hindustan Times (Delhi, Chandigarh), Dainik Bhaskar (Chandigarh, Haryana), Amar Ujala (Chandigarh, Haryana), Hari Bhoomi (Chandigarh, Haryana) vide which the applications were invited for 04 posts (Gen.-03, SC of Haryana-01) of Assistant Labour Commissioner in Labour Department, it is hereby announced that on receipt of requisition for additional 04 posts (Gen.-01, SC of hry.-01, BCA of hry.-02, Ph of hry.-1 (horizontal)) of Assistant Labour Commissioner, the number of posts have been increased from 04 to 08. The revised classification of category wise posts and pay scale as informed by the Government vide its letter No. 6/72/2015-1 अम dated 14.02.2019 which is as under:-

Pay scale : FPL 7 (Initial pay 44900) as per 7th pay Commission.


The candidates who had applied earlier in response to the Advt. No. 12(3)/2015 and corrigendum dated 06.05.2016 need not apply again as their previous applications will be considered. It is clarified that no candidate who have already applied against advertisement No. 12(3)/2015 and corrigendum dated 06.05.2016 shall become ineligible on account of age but must fulfill other eligibility condition. However such candidates can update their qualification, category etc.

The candidate who wish to apply afresh against the Advt. No. 12(3)/2015 for the post of Assistant Labour Commissioner can apply through online mode upto closing date i.e. 04.04.2019. The category wise application fee structure payable through Net banking/Debit/Credit card upto 24:00 hours midnight of closing date i.e. 05.04.2019. Eligibility with regards qualifications, age and other conditions of eligibility etc. will be determined as on last date of submission of online application form 04.04.2019 (closing date of corrigendum).

Note: Candidates are advised not to send the hard copy of the application form. If any candidates sent the hard copy of the application form, the same will not be entertained. However they should retain the hard copy of their online application form for their own record and submission to the Commission as and when sought in the future.
