ANNOUNCEMENT

It is hereby announced for the general information of the candidates who have applied against 246 posts of Veterinary Surgeons (HVS-II) in Animal Husbandry & Dairying Department, Haryana in response to the Advertisement No. 2(viii)/2014 published on 28.04.2014, 6(2)2015 published on 17.11.2015, Corrigendum dated 10.08.2016, 23.08.2016 (closing date 05.09.2016) and re-Advertisement No.1(1)/2017 published on 02.05.2017 in various newspapers, that keeping in view the receipt of large number of online applications and as per condition laid down in the advertisements, the Commission has decided to shortlist the candidates for interview on the basis of the essential academic qualifications as per advertisement i.e. Bachelor of Veterinary Science (B.V.Sc), on percentage basis. The minimum cutoff percentage in B.V.Sc/M.V.Sc Degree is given as under:-


Sr. No.	Category	% age of Marks in B.V.Sc OR M.V.Sc
1.	General	75% or above.
2.	BC-A of Haryana	All the eligible candidates
3.	BC-B of Haryana	All the eligible candidates
4.	EBP (GC) of Haryana	All the eligible candidates
5.	SC of Haryana	All the eligible candidates
6.	PH (Locomotor) of Haryana	All the eligible candidates
7.	ESM/DESM of Haryana	All the eligible candidates

- Note 1: Ph.D candidates will be considered eligible irrespective of their percentage in Bachelor/Master of VS & AH.
- Note 2: Physically Handicapped candidates other than PH (Ortho) will be considered in their respective category.
- Note 3: In case of marks given in the concerned degree as CGPA or Grade Point, then the proof/certificate with regard to percentage of marks in the degree should be required from the Competent Authority/ University.
- Note 4: Reserved category of Haryana certificate should be issued from the parental side.

All the shortlisted candidates with the above mentioned percentage of marks or higher will be interviewed by the Commission. All eligible candidates to be called for interview are hereby directed to submit the Hard Copies of their online application forms alongwith self attested copies of their certificates/supporting documents as claimed in the online application form and also according to the terms of advertisement, to the Commission's Office addressed to the Secretary, HPSC, Bays No. 1-10, Block-B, Sector-4, Panchkula, (Haryana) through registered post or by personal delivery at reception within 15 days from the date of publication in the newspapers and not later than by 14.9.2017 failing which their candidature will not be considered for this recruitment. The eligible candidates are also advised to read the above mentioned notice carefully to comply with the aforesaid instructions and also to attend the interview on the dates as per interview schedule to be published separately, interview letters which will be issued separately after finalisation of the schedule. Candidates who do not possess the minimum cut off percentage of marks as per the above criterion adopted for shortlisting the candidates are not required to send the hard copy of their documents to the Commission.
