Announcement

It is announced for general information of the candidates who have applied in response to Advertisement No. 5 of 2014 published on 26.07.2014 & 1(2) of 2017 published on 02.05.2017 and corrigendum dated 27.11.2017 respectively for 74 posts of Dental Surgeon, Class-II in Health Department, Haryana that the Commission has decided to hold the Recruitment/ Screening test for the above said posts on 15.04.2018 (Sunday) from 10:00 AM to 12:00 Noon in various educational institutions at Chandigarh.

The Admit Cards and Instruction to Candidates for the aforesaid Test will be available on Commission's website from 04.04.2018 and the candidates can download the same from the Commission's website. No separate admit card will be sent to the candidates by the Commission through post/Courier.

The candidates who find any error in the Name, Father's Name, Category, Date of Birth etc. in their admit cards, can contact the Commission's office "in person or on telephone No. 0172-2560754 or mail at hpsccorrections@gmail.com upto 13.04.2018" for necessary rectifications in the Admit Card. Any type of rectification in the admit cards will not be carried out after 13.04.2018 by the Commission.

Notes:

1. A Physically Handicapped (blind/ partially blind / Locomotor disability) candidate who wants the help of a scribe for writing his/her papers with extra time @ 20 minutes per hour, has to make his/her own arrangement of a scribe. The scribe should be a Studying student upto 10+2 and his/her photo and other particulars should be verified by the principal of the institution in which the student is studying.

These Physically handicapped candidates suffering from Locomotor disability who do not want the help of a scribe, extra/compensatory time will be allowed @ 20 minutes per hour for examination on production of a medical certificate issued by a Medical Board clearly stating that the candidate's writing ability is severally affected due to his/her handicapness.

In both the above cases, the candidates have to apply at least 10 days before the commencement of Recruitment Test for which the permission will be granted by the Commission. No such permission will be granted by the centre supervisor.

2. Candidates are directed that they should download the admit card on A-4 size paper so that their photos & other particulars can easily be seen / verified. Candidates having small size Admit Cards with illegible photos / signatures will not be allowed to enter in the Examination centre.
3. The candidates of those categories against which no post was advertised, shall be considered against the vacancies of General category if they fulfill all the conditions of eligibility as meant for General category candidates except fees.
4. The Admit card is not being issued to the candidates who had applied in response to the Advt. No. 5/2014 and 1(2) of 2017 and corrigendum dated 27.11.2017 under BC Category and have yet not updated there BC Category into BC-A or BC-B Category as per above advertisement.
5. The eligibility of candidates belonging to Outstanding Sports Person Category will be adjudged as per Advice/Policy/Instructions/Notification etc. of the Haryana Govt./Department.
6. As per the Haryana Govt. instructions issued vide No. 22/10/2013-1GSIH dated 21.02.2018, the impugned ordinance issued by Govt. in Welfare of Scheduled castes and Backward Classes dated 27.09.2013 regarding EBPG Category have been struck down by the Govt. vide letter No. 22/10/2013-1GSIH dated 21.02.2018 so the final decision regarding their category/candidature will be as per advice of the Govt./Department.
7. All the candidates who had applied for the post of Dental Surgeon Class-II in response to advertisement No. 5 of 2014 and 1(2) of 2017 and Corrigendum dated 27.11.2017 published on 29.11.2017 are being allowed to appear in the said test provisionally subject to the fulfillment of all eligibility conditions as mentioned in advertisement No. 5/2014 published on 26.07.2014 & 1(2) of 2017 published on 02.05.2017 and Corrigendum dated 27.11.2017 published on 29.11.2017.
8. For those candidates who have not uploaded their required size of photograph and signature on their online application forms, a note to this effect will be displayed on the website at the time of downloading of admit card. Such candidates are directed to send their photograph and signature on the website at hpsccorrections@gmail.com upto 13.04.2018 failing which they will not be in a position to download their admit card. In such circumstances the candidates himself will be liable for consequences.
