No. G.S.R. 69/Const./Art./320/73- In exercise of the powers conferred by the proviso to clause (3) of article 320 of the Constitution of India, and all other powers enabling him in the behalf, the Governor of Haryana hereby makes the following Regulations specifying the matters in which shall not be necessary to consult the Haryana Public Service Commission, namely:-

**PART-I Preliminary**

1. These regulations may be called the Haryana Public Service Commission (Limitation of Functions) Regulations, 1973.
2. In these Regulations, unless there is something repugnant in the subject or context:-
  - (i) "Commission" means the Haryana Public Service Commission.
  - (ii) "Initial appointment" means as appointment in the first instance to a service or post which does not involve the promotion or transfer or any one already in the service of the Haryana Government.

**PART-II Limitations**

3. It shall not be necessary to consult the Commission on the suitability of candidates for:-
  - a) initial appointments to all non-gazetted Group-C and Group-D posts;
  - b) initial appointment to services or posts enumerated in the schedule 'A'/- here to annexed.
  - c) appointment to a temporary post, the necessity for which is declared at the time of its creation to be unlikely to continue for more than 6 months.
  - d) appointment to a permanent post of a person temporarily for a period not exceeding six months, if owing to an emergency having arisen, it is necessary in the Public interest to fill the vacancy immediately and there is likely to be undue delay in making the appointment after consultation with the Commission.
  - \*e) Promotion or transfer from one service or post to another service or post to which an initial appointment is not referable to the Commission;

- f) Officiating promotions or transfers to any service or post when at the time of making the promotion or transfer there is reason to suppose that the officiating promotion or transfer will be for not more than six months;
- g) Officiating appointment made by transfer from one service or post to another on grounds of public interest, not involving an element of promotion in terms of higher pay scale, when such an appointment does not exceed a period of one year;
- h) Appointment to any service or post if such candidates have been Government servants who have retired on pension from the same service or from the same post or from a higher class of service or form a higher post of a similar nature;
- i) Absorption in a regular allied service of a person who had been recruited initially on a temporary basis in consultation with the Commission and who has rendered satisfactory service under the Haryana Government for a period of at least 10 years and is considered suitable for permanent appointment.
- j) Appointment by promotion or transfer from other services or posts to the services or posts enumerated in Schedule 'C' here-to annexed.
- k) Appointment of an I.A.S. Officer or a member of the State Civil Service on the Select List as prepared and maintained under the Indian Administrative Service (Appointment by promotion) Regulations, 1955, to an ex-cadre post;
- l) Appointment by deputation or transfer of officers serving under the Government of India or any State Government except the State of Haryana.
- m) Promotions and transfer from one service or post to another service or post pertaining to non-gazetted Class-III and Class-IV posts;
- n) Temporary or officiating appointments to a post which is expressly created in connection with an emergency with respect to which a proclamation under Clause(1) of article 352 of the Constitution is issued; provided that the person to be appointed to such a post is not likely to hold it longer than the period of the Emergency or three years whichever is less;

\*o) Promotion from one cadre to another within the same service.

\*\*p) Promotion to Group A and B posts.

\*\*\*q) Initial appointment to the post of Medical officer in Haryana Civil Medical Service-II in Health Department.

Explanation: - For the purpose of Clause (K) an ex-cadre post would mean a temporary post created in the Senior Scale of I.A.S. outside the I.A.S. cadre.

4. It shall not be necessary to consult the Commission in respect of any of the matters mentioned in sub-clauses (a) to (e) of clause (3) of Article 320 of the Constitution of India in the case of Class-III and Class-IV Government employees.

5. It shall not be necessary to consult the Commission in respect of the matters mentioned in sub-clause (e) of Clause (3) of Article 320 of the Constitution of India in the case of Class III and Class IV Government employees.

6. It shall not be necessary to consult the Commission:-

(a) On any original or appellate order connected with the matter of discipline when such order is proposed to be made by an authority subordinate to the Haryana Government, except on any original order proposed to be made by such authority imposing any of the following penalties in the case of Class II Officers:-

- (i) Withholding of increments or promotion, including stoppage at an efficiency bar for more than one year with non-continuing effect;
- (ii) Recovery from pay of the whole or part of any pecuniary loss caused to Government by negligency or breach of orders;

(b) On any original order proposed to be made by the Haryana Government imposing any of the following penalties:-

- (i) Censure
- (ii) Withholding of increments or promotion, including stoppage at an efficiency bar for not more than one year with non-continuing effect.

- (c) On any order proposal to be made by the Haryana Government on appeal, other than an order enhancing the penalty to that for which consultation with the Commission would have been necessary in case the enhanced penalty had been imposed in an original order, when the order appealed against is one of:-
    - (i) Censure.
    - (ii) Withholding of increment or promotion including stoppage at an efficiency bar for not more than one year with non-continuing effect.
  - (d) On any petition or memorial connected with a matter of discipline unless it is proposed to revise previous decision;
  - (e) On any case-
    - (i) relating to the termination of the probation of any person;
    - (ii) relating to the discharge or reversion of an officer otherwise than as a penalty;
    - (iii) relating to the termination of the employment of any person in accordance with the terms of the contract of his employment;
    - (iv) relating to the imposition of any penalty laid down in any rule or order for failure to pass any test or examination within specified time or;
    - (v) in which the Commission has at any previous stage given advice in regard to the orders to be passed and no fresh question has thereafter arisen for determination, unless it is proposed to reverse a previous decision;
  - (f) disciplinary matters pertaining to Class-III and Class-IV Government Employees;
  - (g) on the methods of recruitment and the principles to be followed in making appointments to posts which are not whole time posts and to posts enumerated in Scheduled 'B' hereto annexed;
  - (h) on the methods of recruitment and the principles to be followed in making a temporary or officiating appointment to a post which is expressly created in connection with an emergency with respect to which a proclamation under clause (i) of Article 352 of the Constitution is issued, provided the person to be appointed to such a post is not likely to hold it longer than the period of the Emergency or three years, whichever is less.
7. Repeal:- The Punjab Public Service Commission (Limitation of Functions) Regulations, 1955, are hereby repealed):
- Provided that any order made or action taken under the regulations so repealed shall be deemed to have been taken under the corresponding provisions of these regulations.
