8. **Application Fees:** The online application fees which is payable at all branches of State Bank of Patiala and State Bank of India, is as under:-

Note I: Procedure for deposit of Fee:- Candidates are advised to take print out of the application form and fee Challan and deposit the fee in any branch of State Bank of India and State Bank of Patiala after 48 hours of filling online application and Challan generation before **29.08.2016**.
