ANNOUNCEMENT

The Commission vide advertisement No.41/2022 published on 11.12.2022 with closing date 05.01.2023, has advertised 383 post of Veterinary Surgeon in Animal Husbandry & Dairying Department, Haryana. The essential qualification for the post is as under:-

ESSENTIAL QUALIFICATIONS:

- (i) Bachelor of Veterinary Science and Animal Husbandry from a recognized University or Institution;
- (ii) Adequate Knowledge of Hindi.
- (iii) Registered as Veterinary Practitioner with Haryana Veterinary Council or with any Veterinary Council in India or Indian Veterinary Council as required by Indian Veterinary Council Act, 1984.

Preferential:-

Ph.D. or Master of Veterinary Science in Animal Genetics and Breeding/ Veterinary Gynecology/ Animal Physiology or in any branch of Animal Husbandry/ Veterinary Science.

Some candidates have filed writ petitions in the Hon'ble High Court with a prayer to allow them to participate in the selection process. The Hon'ble High Court vides its interim order dated 19.12.2022 passed in CWP No. 29247, 29347/2022 titled as Anil Kumar & others Vs State of Haryana and others has directed as under :-


"Meanwhile, the petitioners be allowed to appear provisionally in the selection process and their result be kept in sealed cover".

Similar order has been passed in CWP No.29614/2022. Further in CWP No.29936/2022 the Hon'ble High Court vides its interim order dated 26.12.2022 has directed as under:-

"In the meantime, the respondent No.4 Haryana Public Service Commission, is directed to accept the application of the petitioners on provisional basis and allow them to participate in the interviews, however, the result will be declared subject to their clearing the Internship Program".

The Commission has considered the matter and in compliance of the above interim order, it has been decided that the petitioners in CWP Nos. 29247, 29347, 29614 & 29936/2022 are directed to apply offline in the format of application form which is available on the Commission's website i.e. <https://hpsc.gov.in>. The duly filled application forms alongwith copy of the orders of the Hon'ble Punjab & Haryana High Court will be accepted by the Commission latest **upto 04:00 PM on 05.01.2023**. Application fees shall be accepted through Bank Draft in favour of Secretary, Haryana Public Service Commission, payable at Panchkula. Other terms & conditions will remain unchanged. It is also made clear that only the application forms of petitioners of CWP's mentioned above would be accepted by the Commission when the copy of the Hon'ble High Court order is enclosed with the application form. No further request/ correspondence would be entertained after the closing date i.e. 05.01.2023.
