## RESULT (FINAL)

On the basis of Haryana Civil Service (Judicial Branch) Main Examination 2020-2021 held from 20.05.2022 to 22.05.2022 at Panchkula and Interviews of qualified candidates held from 05.09.2022 to 23.09.2022, the Selection Committee, Constituted by Haryana Government has finalized the result and recommended the candidates bearing following Roll Numbers in each category for appointment to the posts of Civil Judge (Junior Division) in the State of Haryana.
